## **Mayflower Golf Club Member Disclaimer & Conditions**

I hereby acknowledge that I am entitled to membership benefits at the Mayflower Golf Club (hereinafter referred to as "Club") only so long as I am a member in good standing. Good standing status determination is at the sole discretion of the Club owner. Good standing status may be lost as a result of, but not limited to, damage to Club property, damage to other golfers' property, theft, enabling theft, violation of Club rules, inappropriate behavior towards Club staff, purchasing alcoholic beverages for minors, etc. I acknowledge that lying about my age or my child's age to achieve a cheaper membership rate is theft. Should I lose my good standing status, my membership benefits as well as those of any minors added to my membership will be terminated and no refund of membership cost shall be received. If the Club allows me to return at a future date, I acknowledge that the Club reserves the right to charge me a damage deposit, refundable at the end of the season. I agree to pay for any damage caused to Club property by myself or any minor(s) added to my membership within 5 days of said damage occurring, unless otherwise agreed to with Club management. I acknowledge that I am legally and financially responsible for any minors that I add to my membership and that any minors added to my membership will lose their membership privileges if they lose their good standing status. Should any said minors inflict damage to any property of the Club, I acknowledge that I must pay for said damages before using any services of the Club again. Should I fail to pay for the damages, I understand that both myself and my minors will lose our good standing status. If I store my golf cart, golf clubs, or any other belongings at the Club, I acknowledge that the Club is not responsible for any damages to my property that may occur, whether by vandalism, fire, natural causes, etc. I acknowledge memberships are nonrefundable. I agree to follow all Club Rules of the Mayflower Golf Club written below.

### Rules of the Mayflower Golf Club

#### **Dress Code:**

- 1. No metal spikes allowed, only soft spikes permitted
- 2. Shoes and shirt required at all times
- 3. No boots allowed on course

#### Golfers:

- 1. All players, including members, must register in clubhouse prior to play
- 2. The place for practice is the driving range or practice green, not the golf course, as pace of play needs to be maintained
- 3. No food or beverages allowed on course unless purchased in clubhouse
- 4. You **MUST** fix your ball marks on the green, using a divot repair tool
- You <u>MUST</u> fill your divots on the tee box, fairway, and rough, using a sand bottle
- 6. Do not leave broken tees on tee boxes; place them in tee disposal boxes or trash cans
- 7. Rake the sand bunker after hitting out of it
- 8. Let faster golfers play through
- 9. No throwing clubs
- 10. No swinging clubs into the ground
- 11. Stay out of roped-off areas
- 12. Stay out of the creek, ravines, and woods
- 13. Nobody allowed on course after sunset
- 14. No more than 5 golfers per group
- 15. No dogs or other pets allowed on course or in clubhouse (with exception of service dogs)
- 16. Horseplay, unsportsmanlike conduct, loud profanity, unruly spectators, or any noises or disturbances that distract players will not be tolerated

#### **Golf Carts:**

- 1. Rental carts shall be paid for in advance for the designated number of holes
- 2. Trail fees must be paid for private carts brought onto the course, unless the cart is stored at the Mayflower
- 1. No golf carts allowed within 40 feet of the green
- 2. Keep carts out of wet areas
- No more than two people per rental cart (with exception of small children)
- 4. Only one person allowed per Golf Board
- 5. Return cart keys to clubhouse after golfing
- 6. Remove trash from your rental cart after golfing
- 7. Keep off maintenance paths
- 8. No rental carts allowed in tall grass
- 9. No carts allowed in sand traps
- 10. All golf carts stored at Mayflower are required to have at least 1 sand bottle, either mounted to cart or carried inside cart
- 11. Anyone abusing the privilege of using a golf cart may be removed from the golf course
- 12. You must be at least 16 years old to rent and/or operate a rental cart or golf board
